



## Suggested Will Wording

Leaving a gift to Children Believe in your Will takes some planning. You and your lawyer/notary or estate planner can use the sample clauses below to add as a codicil to an existing Will or within a new one. We encourage you to have your lawyer/notary or estate planner review any wording.

### Specific Amount, unrestricted:

I give, devise and bequeath to Children Believe Fund (#10691 8543 RR0001) the sum of \$\_\_\_\_\_ to be used for any purpose(s) approved by the Board of Directors of Children Believe.

### Specific Amount, restricted:

I give, devise and bequeath to Children Believe Fund (#10691 8543 RR0001) the sum of \$\_\_\_\_\_ to be used for the following purpose(s) \_\_\_\_\_.

\_\_\_\_\_ . If Children Believe is unable to apply all or part of these funds for the specific purpose(s) stated herein, the balance of this bequest not so extended may be used for any purpose approved by the Board of Directors of Children Believe.

### Residual %, unrestricted:

I give, devise and bequeath to Children Believe Fund (#10691 8543 RR0001), \_\_\_\_\_% of the residue of my estate to be used for any purpose(s) approved by the Board of Directors of Children Believe.

### Residual %, restricted:

I give, devise and bequeath to Children Believe Fund (#10691 8543 RR0001), \_\_\_\_\_% of my estate to be used for the following purpose(s) \_\_\_\_\_.

### Sponsorship continuation\*:

**\*To ensure bequests are aligned with our community development mission, we don't advise including a specific sponsored child's name in your Will, however, you can include sponsorship continuation of your current child/ren in this way:**

I give, devise and bequeath to Children Believe Fund (#10691 8543 RR0001) \$\_\_\_\_\_ (or the residue of my estate) to be used to continue monthly sponsorship of the child/ren I am sponsoring at the time of my death, until their graduation. Should I not be sponsoring any

child/ren at the time of my death or if there is any remainder following graduation, this gift is to be used for any purpose(s) approved by the Board of Directors of Children Believe.

**Residual contingent trust:**

Upon the death of the survivor of my (wife, husband, etc.) \_\_\_\_\_ and my (son, daughter, etc.) \_\_\_\_\_, I direct my trustee to transfer and deliver the balance of the residue of my Estate, including any undistributed income to Children Believe Fund (#10691 8543 RR0001) to be used for any purpose(s) approved by the Board of Directors of Children Believe.
